Producer Price Index in Iran

Ordibehesht 1397

(1390 = 100)

The Producer Price Index (PPI) went up 1.8 percent in Ordibehesht 1397 following an increase of 0.3 percent in Farvardin 1397. The index level of 271.2 was 14.8 percent higher than in Ordibehesht 1396.

For the first 2 months of 1397, the PPI edged up 13.8 percent, compared to the similar period in 1396.

This index moved up 11.3 percent for the 12 months ended in Ordibehesht 1397.

Agriculture, forestry and fishing: In Ordibehesht, a 2.2-percent increase in the prices of this group can be traced to the rises in the indices for colza, greengage, raising of cattle and buffaloes, raising of sheep and goats, egg and aquaculture. In contrast, prices for melons, carrots, garden vegetables, poultry and Persian Gulf fish went down.

Manufacturing: The Manufacturing group index moved up 2.3 percent, which was mostly due to the rises in the indices for slaughter livestock and poultry, meat products, canned fish, chips, dried nuts and fruits, cooking oil, oil cake, pasteurized milk, sugar, tomato paste, dry tea, livestock and poultry feed, manufacture of beverages, cigarettes, machine-made carpet, upper leather, tissue paper, lube cut, raffinate, manufacture of basic chemicals,

pesticides and insecticides, "manufacture of soap and detergents, cleaning and polishing preparations, perfumes and toilet preparations", industrial adhesive, synthetic fibers, gastrointestinal medicine, "sponge, integral and foam", refractory brick, bricks and clay, ceramics, building insulations, foundry sand, manufacture of basic iron and steel, aluminium ingot, casting of metals, metal cans, electrode, CD and DVD, television, electric supply meters, transformer, battery of car, copper wire, cable, outlet and socket, manufacture of domestic appliances, "manufacture of compressors, pumps and taps", lift truck, sewing machine, automobile, pickup truck, axle of car, motorcycles, making gold, and syringe and needle. On the contrary, prices for exported urea, manufacture of plastics and synthetic rubber in primary forms, cement pipe and copper products declined.

Services: Increases in the indices of urban bus trip fare, subway fare, hotel accommodation cost, movie ticket and pre-primary school tuition fees mainly led to 0.9 percent rise in the services group.


