Export Price Index in Iran

Farvardin 1397

(1390 = 100)

The Export Price Index (**XPI**) increased 8.4 percent in Farvardin 1397^{*} following a 1.7 percent decline in Esfand 1396. The index level of 344.3 was 42.9 percent higher than in Farvardin 1396.

The XPI has advanced 23.1 percent over the past twelve months.

In Farvardin, the animal products group index moved up 9.8 percent, which was mainly due to the rises in the prices for yogurt, frozen fish, and sheep assorted casing.

The vegetable products group index advanced 10.1 percent. The mentioned rise was attributed to the increases in the prices for pistachio, saffron, raisin, date, liquorice extract powder, and shelled almond.

The 15.7 percent increase in the animal or vegetable fats and oils group index was mainly due to the rise in the price for soya oil.

The prepared foodstuffs, beverages and tobacco group index turned up 7.8 percent, largely due to the rises in the prices for biscuit and wafer, tomato paste, ice cream, cake, non-cacao chocolate, potato chips, fruit juice, chewing gum, and chocolate.

During the mentioned month, the group index for mineral products rose 8.6 percent. Increases in the prices for propane, butane, industrial oil, cement, bitumen, paraffin wax, copper concentrate, and engine oil were the major reasons for this advance.

^{*} The index is computed on the Iranian Rial basis. In this month, the exchange rates of Dollar and Euro increased 7.6 percent and 6.9 percent, respectively.

The products of the chemical or allied industries group index went up 7.8 percent. Higher prices for methanol, urea fertilizer, styrene, alkyd anti-corrosion primer, "detergent powders and liquids", ammonia, dodecyl benzene, caustic soda, molybdenum oxide, glue, shampoo, and crystal melamine were the main factors for the mentioned advance. In contrast, the price for spray paint decreased.

The 7.7 percent increase in the plastics and articles thereof, rubber and articles thereof group index was led by rises in the prices for high density polyethylene, low density polyethylene, plastic hoses, motorcycle tire, and polystyrene.

During this month, increase in the price for processed sheep skin led to the rise in the group index for skins and leather and articles thereof by 9.3 percent.

In Farvardin, the group index for wood and articles of wood turned up 12.6 percent.

Mostly as a result of increasing in the prices for hand-woven carpet, machinemade carpet, gunny, and rug, the textiles and textile articles group index moved up 9.1 percent, over this month.

The footwear group index went up 7.6 percent, largely due to the increases in the prices for "sandal with uppers of rubber or plastics" and "shoe with uppers of rubber or plastics".

The articles of stone group index advanced 6.5 percent. The rise was driven by increasing prices for "tile and ceramic", float glass, building stone, and sanitary porcelain.

As a result of rising in the prices for hot coil iron, aluminum ingot, cathode copper, zinc ingot, lead ingot, galvanized pipes, iron beam, and ferromolybdenum, the base metals and articles of base metal group index increased 7.7 percent.

Increases in the prices for air cooler, cable, and gas water heaters caused 8.4 percent advance in the machinery and mechanical appliances, electrical equipment group index.

The vehicles and associated transport equipment group index advanced 10.9 percent over this month, mainly due to the rises in the prices for tractor, and car radiator.


