



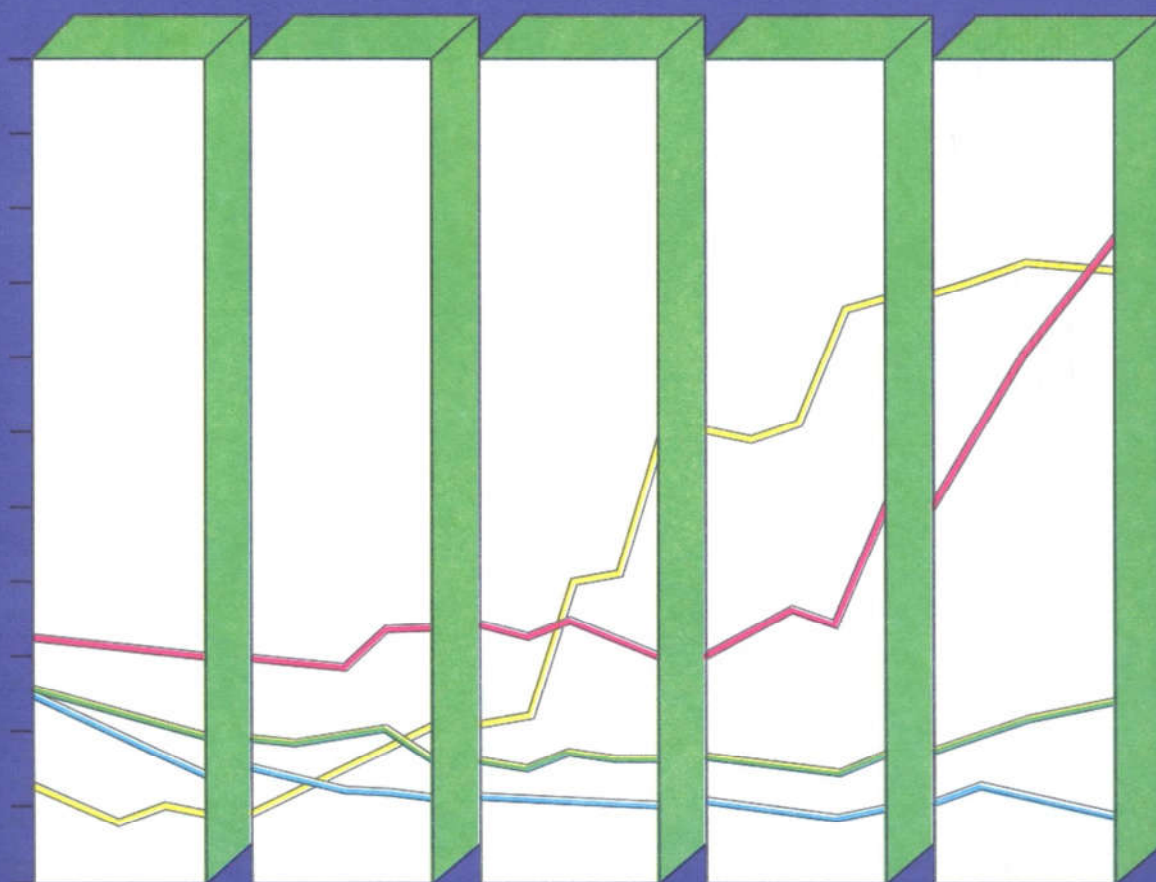

Producer Price Index in Iran

Aban 1397

The Producer Price Index (PPI) went up 3.5 percent in Aban 1397. The index level of 182.1 was 63.3 percent higher than in Aban 1396.

For the first 8 months of 1397, the PPI edged up 34.4 percent, compared to the similar period in 1396.

This index moved up 26.9 percent for the 12 months ended in Aban 1397.

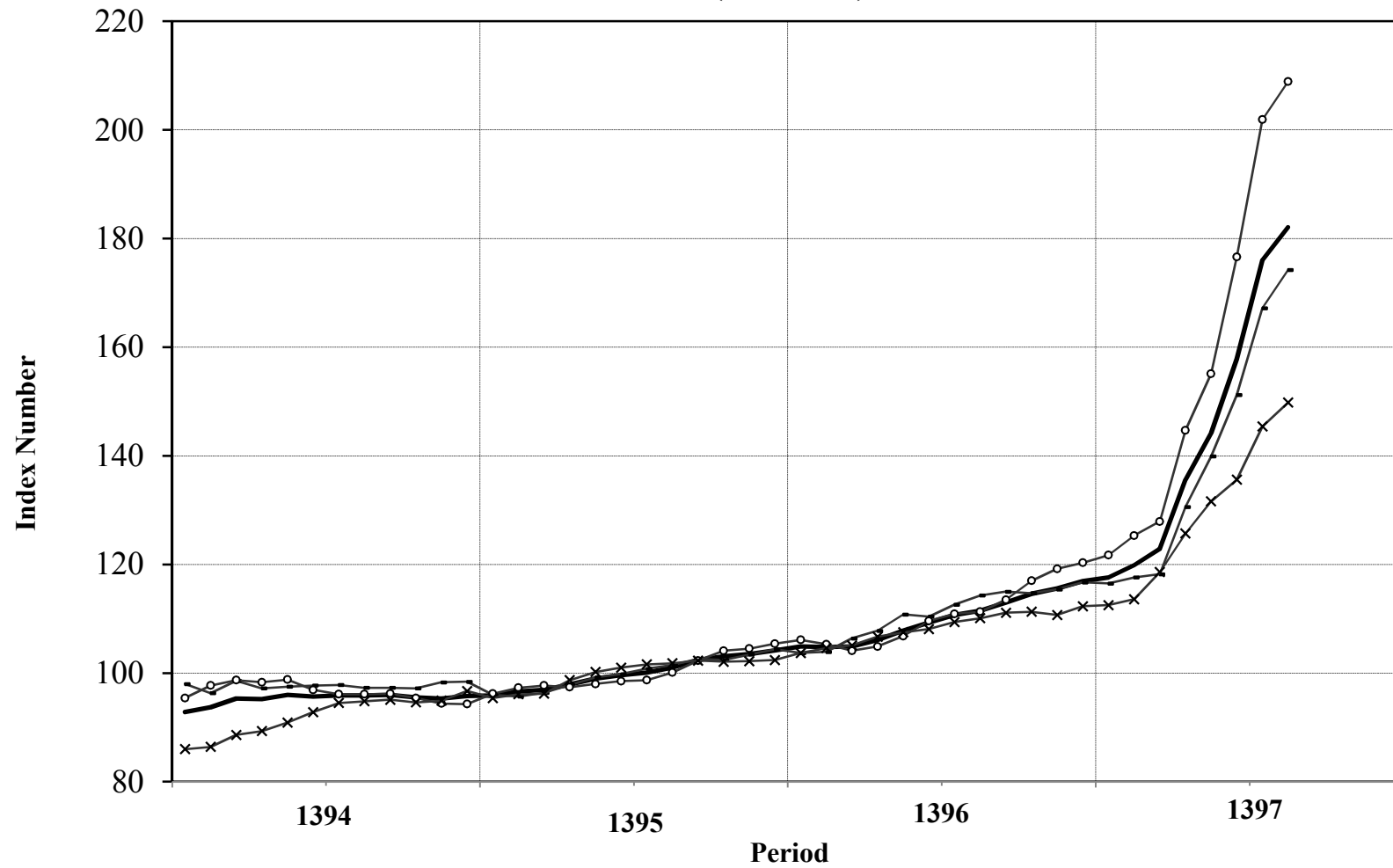
Agriculture, forestry and fishing: In Aban, a 4.2-percent increase in the prices of this group can be traced to the rises in the indices for oil seeds, pulses, eggplants, onions, snap beans, growing of tobacco, growing of cotton, saffron, citrus fruits, apples, walnuts, olives, animal production, and fishing and aquaculture. In contrast, prices of squash, lemons and pomegranates went down.

Manufacturing: The Manufacturing group index moved up 3.5 percent, which was mostly due to the rises in the indices for preparation of frozen fishes, manufacture of potato crisps, dried nuts, manufacture of vinegar, wheat brans, manufacture of bakery products, manufacture of molasses and bagasse, ketchup sauces, tea and mate, manufacture of yeast, synthetic yarns, weaving of textiles, manufacture of carpets and rugs, men's shirts, heavy overcoat and anorak, "manufacture of products of wood, cork, straw and plaiting materials",

"manufacture of pulp, paper and paperboard", manufacture of coke, jet propulsion fuel (type 4), pentane, ethane, "manufacture of oils, lubricating oils and heavy refined petroleum products", tar, manufacture of domestic basic chemicals, domestic fertilizers and nitrogen compounds, manufacture of plastics and synthetic rubber in primary forms, low density polyethylene, styrene, manufacture of pesticides and other agrochemical products, enamels and ferrite, soap and hand washing liquid, antifreeze, tire cord, "manufacture of pharmaceuticals, medicinal chemical and botanical products", manufacture of plastics products, manufacture of glass and glass products, manufacture of porcelain, concrete, manufacture of iron and steel pipe, iron plates, sponge iron, iron profile, casting products, manufacture of metal tanks and reservoirs, electrodes, manufacture of optical disk drives, manufacture of televisions, manufacture of radio receivers, manufacture of distribution transformers, high voltage circuit breakers, manufacture of domestic appliances, manufacture of ball bearings, lift trucks, manufacture of fan coil units, industrial ventilator, ploughs, milling machines, manufacture of buses, manufacture of parts and accessories for motor vehicles, and manufacture of motorcycles. On the contrary, prices for exported ammonia, polypropylene, angle iron, gas meter, manufacture of cooling electric motors and manufacture of fluorescent lamps declined.

Services: Increases in the indices of goods transport via railways, inns cost, pre-primary school tuition fees and university tuition fees led to 3.0 percent rise in the services group index.
