



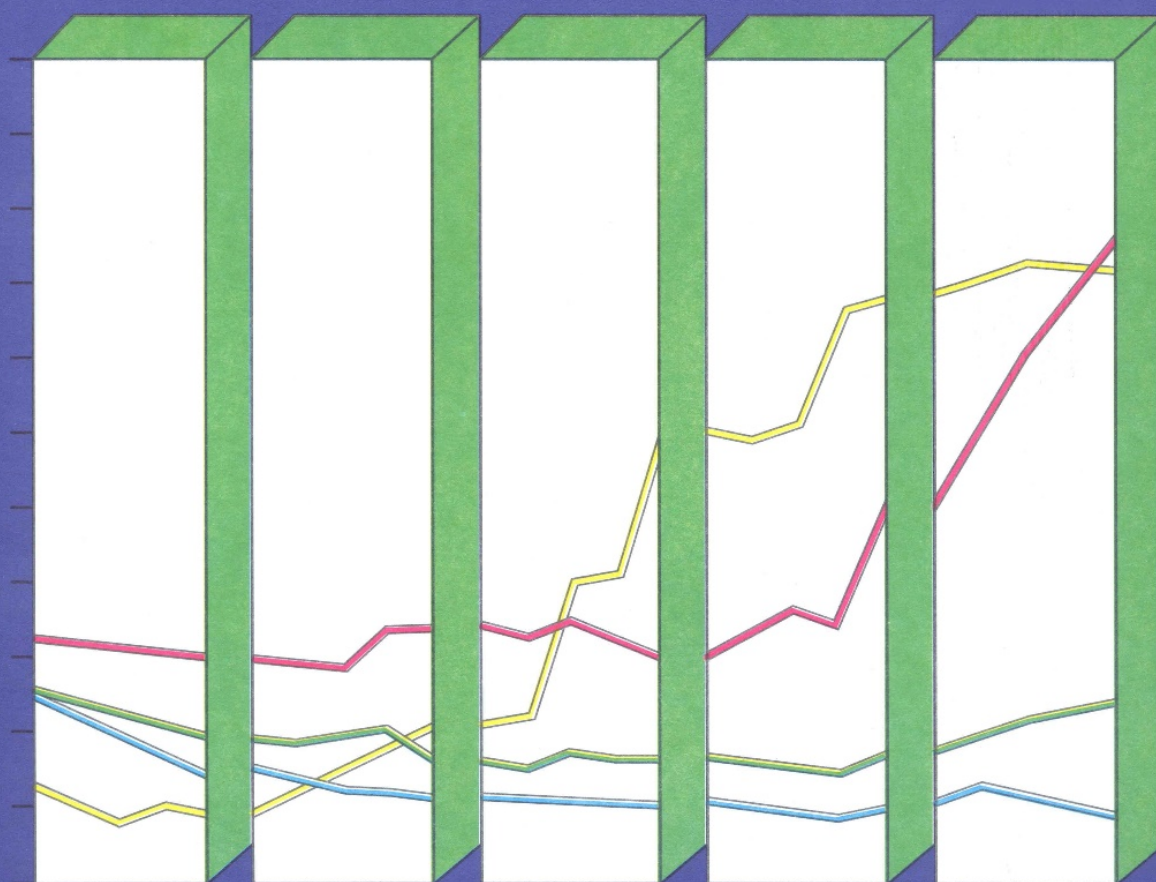

## **Producer Price Index in Iran**

*Azar 1397*

**(1395 = 100)**

The Producer Price Index (PPI) went down 4.5 percent in Azar 1397. The index level of 173.9 was 53.9 percent higher than in Azar 1396.

For the first 9 months of 1397, the PPI edged up 36.7 percent, compared to the similar period in 1396.

This index moved up 30.6 percent for the 12 months ended in Azar 1397.

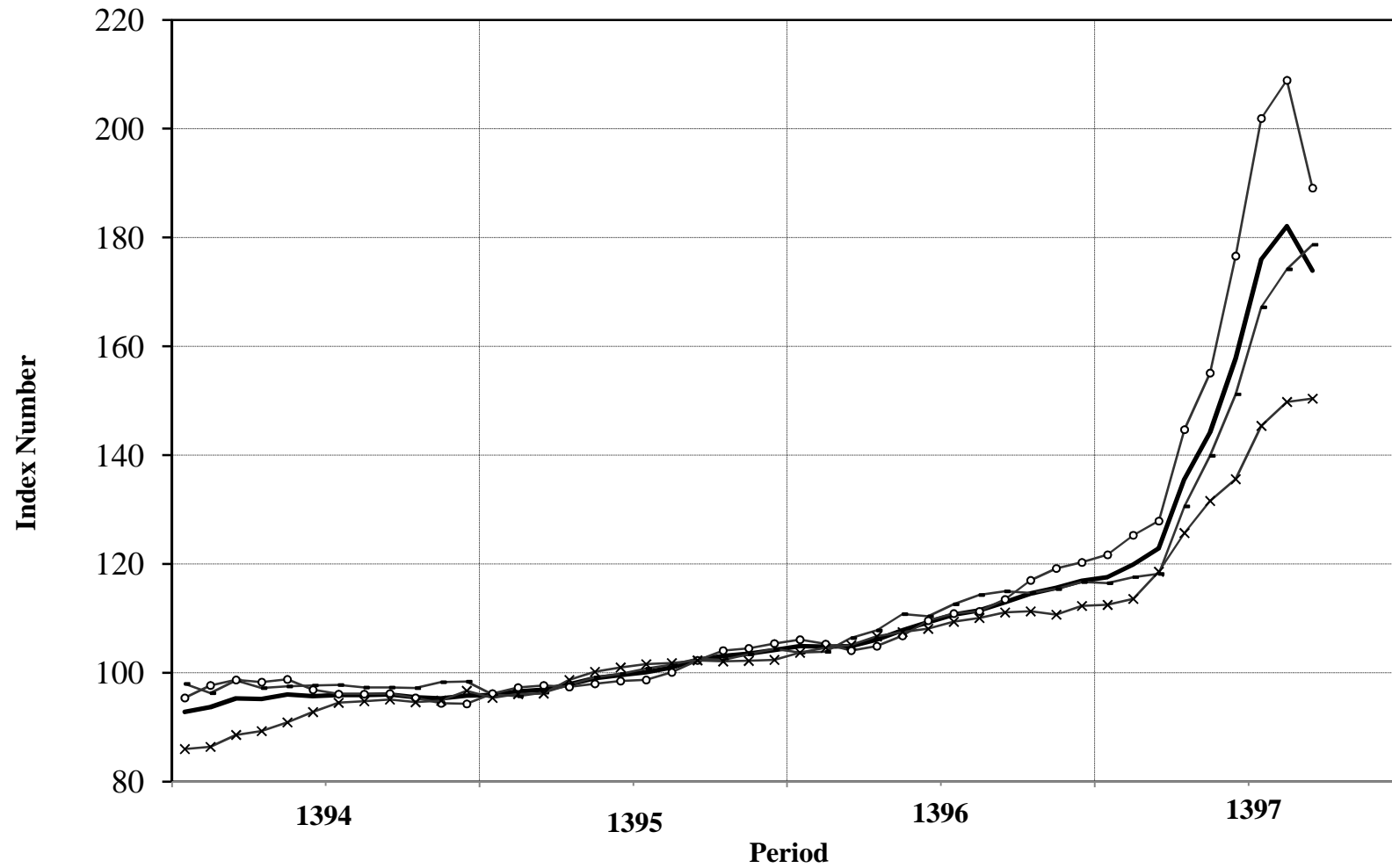
**Agriculture, forestry and fishing:** In Azar, a 2.6-percent increase in the prices of this group can be traced to the rises in the indices for grain maize, eggplants, squash, carrots, turnips, growing of leaf vegetables, cotton, alfalfa, animal production, Persian Gulf fish and fish farming in freshwater. In contrast, prices of tomatoes, snap beans, saffron, lemons and Caspian Sea fish went down.

**Manufacturing:** The Manufacturing group index moved down 9.5 percent, which was mostly due to the falls in the indices for manufacture of soya protein, mineral water, cigarettes, kraft and brown paper, coke, pentane, basic chemicals, low density polyethylene, high density polyethylene, synthetic fibers, plastic pipes and fittings, basic metals, burrow, metal cans, power transformers, wires, ball bearings, burners and "disc and clutch plate". On the

contrary, prices for slaughter livestock and poultry, preparation of frozen fishes and shrimp, manufacture of canned fruits, dried nuts, oil cake, "fresh liquid milk, pasteurized, sterilized, homogenized or ultra heat treated", wheat bran, "cocoa, chocolate and sugar confectionery", canned stews, livestock and poultry feeds, textiles, tissue paper, brake fluid, raffinate, paraffin wax and Vaseline, fertilizers and nitrogen compounds (domestic use), polypropylene, polybutadiene rubber, "soap and detergents, cleaning and polishing preparations, perfumes and toilet preparations", car tyre, rubber compounds, "sponge, integral and foam", glass and mirrors, manufacture of prefabricated buildings mainly of metal, video door phones, speaker systems, industrial electromotor, batteries for vehicles, lamps, domestic electric appliances, pumps, lifting and handling equipment, industrial refrigerators and freezers, combine, buses, "filters for internal combustion engines and motor" and mattresses went up.

**Services:** Increases in the indices of restaurants and cinema tickets led to 0.4 percent rise in the services group index. In this group, the index of transportation and storage declined.
