Wholesale Price Index in Iran

Khordad 1386

(1376 = 100)

The Wholesale Price Index (**WPI**) went up 0.6 percent in Khordad 1386. Showing the index point of 326.2, the **WPI** was 14.7 percent higher than the similar month in 1385.

During the first three months of the current Iranian year, the Wholesale Price Index rose 16.1 percent compared to the similar period in 1385.

The Wholesale Price Index increased 14.8 percent during the last twelve months leading to Khordad 1386 compared with the similar preceding period.

In Khordad, the food group index declined 0.2 percent.

The beverages and tobacco group index advanced 3.3 percent.

The crude materials, inedible, except fuels group index went up 1.8 percent, which was mainly attributed to the rise in the prices of skins and casings and exported processed sheep skins.

The advance in the price of gasoline mainly caused 8.6 percent increase in the group index of mineral fuels and related materials.

The chemical and petrochemical products group index went up 1.5 percent, which was mainly due to the rise in the prices of P.V.C. (domestic

use), exported propane and butane, paint and ink and plastics in primary forms and synthetic rubber.

The manufactured goods classified chiefly by materials group index and the machinery and transport equipment group index increased 0.4 percent each.

The miscellaneous manufactured articles group index went up 0.5 percent.

In the special groups, the farm, livestock and fishing products group index and the building materials group index fell 0.4 percent and 0.2 percent, respectively.


