Wholesale Price Index in Iran

Tir 1386

(1376 = 100)

The Wholesale Price Index **(WPI)** went up 1.7 percent in Tir 1386. Showing the index point of 331.8, the **WPI** was 15.9 percent higher than the similar month in 1385.

During the first four months of the current Iranian year, the Wholesale Price Index rose 16.0 percent compared to the similar period in 1385.

The Wholesale Price Index increased 15.3 percent during the last twelve months leading to Tir 1386 compared with the similar preceding period.

In Tir, the food group index went up 1.8 percent, which was mainly attributed to the rise in the prices of mutton, the Persian Gulf fishes, dairy products, rice (home produce), barley (home produce), apples, date (domestic use) and honey. In this group, the prices of chicken, pulses, garden vegetables and exported pistachio declined.

The beverages and tobacco group index and the crude materials, inedible, except fuels group index increased 0.1 percent and 1.0 percent, respectively.

The mineral fuels and related materials group index and the chemical and petrochemical products group index went up 0.6 percent and 0.9 percent, respectively.

The advance in the prices of tires and tubes, imported fabrics, bricks, tiles, asphalt, exported hot coil iron, iron wire and iron belt, black iron pipe, iron profile, copper, steam boilers, imported bolts and nuts, taps and electrodes (home produce) mainly caused 2.6 percent rise in the group index of manufactured goods classified chiefly by materials. In this group, the prices of hand-made carpets and rugs (domestic use) and some products of aluminum fell.

The machinery and transport equipment group index increased 0.6 percent.

The miscellaneous manufactured articles group index went up 2.8 percent, which was mainly due to the rise in the price of shoes.

In the special groups, the farm, livestock and fishing products group index and the building materials group index increased 1.8 percent and 3.1 percent, respectively.


