Wholesale Price Index in Iran

Aban 1386

(1376 = 100)

The Wholesale Price Index (**WPI**) went up 1.5 percent in Aban 1386. Showing the index point of 341.9, the **WPI** was 15.0 percent higher than the similar month in 1385.

During the first eight months of the current Iranian year, the Wholesale Price Index rose 15.1 percent compared to the similar period in 1385.

The Wholesale Price Index increased 15.6 percent during the last twelve months leading to Aban 1386 compared with the similar preceding period.

In Aban, the food group index went up 2.1 percent, which was mainly attributed to the rise in the indices of mutton, the Persian Gulf fish, unprocessed milk, fruits with seeds and pits, garden vegetables, pistachio (domestic use) and butter oil. In this group, the indices of corn, leaf vegetables and date declined.

The beverages and tobacco group index had no change.

The crude materials, inedible, except fuels group index increased 0.6 percent.

The advance in the index of motor oil and exported tar mainly caused 1.0 percent rise in the group index of mineral fuels and related materials.

The chemical and petrochemical group index moved up 2.3 percent, which was mainly due to the increase in the indices of exported sulfur, exported benzene and exported propane and butane.

The advance in the indices of truck and bus tire, paper for newspaper (home produce), cement sheet, asphalt and iron and steel mainly caused 1.3 percent rise in the group index of manufactured goods classified chiefly by materials. In this group, the indices of copper wire and exported copper fell.

The machinery and transport equipment group index went up 0.2 percent.

The miscellaneous manufactured articles group index decreased 0.3 percent.

In the special groups, the farm, livestock and fishing products group index and the building materials group index rose 2.5 percent and 2.4 percent, respectively.


