## Wholesale Price Index in Iran

Bahman 1386

(1376 = 100)

The Wholesale Price Index (**WPI**) went up 2.8 percent in Bahman 1386. Showing the index point of 365.8, the **WPI** was 14.5 percent higher than the similar month in 1385.

During the first eleven months of the current Iranian year, the Wholesale Price Index rose 14.6 percent compared to the similar period in 1385.

The Wholesale Price Index increased 14.8 percent during the last twelve months leading to Bahman 1386, compared with the similar preceding period.

In Bahman, the food group index went up 4.0 percent, which was mainly attributed to the rise in the indices of "mutton", "Caspian Sea fish", "Persian Gulf fish", "pulses", "rice (domestic use)", "fresh fruits and vegetables" and "date (domestic use)". In this group, the price for "chicken" and "egg" declined.

The beverages and tobacco group index and the crude materials, inedible, except fuels group index moved up 0.3 percent and 7.3 percent, respectively.

The mineral fuels and related materials group index fell 0.1 percent.

The advance in the price for "exported benzene", "exported ammonia", "medicine (home produce)" and "ammonium nitrate" principally caused 2.7 percent increase in the group index of chemical and petrochemical products. In this group, the indices of "exported propane" and "exported butane" moved down.



The manufactured goods classified chiefly by materials group index went up 1.7 percent. This advance was mainly due to the rise in the indices of "hand-woven carpet and rug", "machine-made rug", "brick", "iron and steel", "copper wire" and "metal structure". In this group the price for "cement sheet" and "porcelain (domestic use)" decreased.

The machinery and transport equipment group index moved up 0.9 percent.

The increase in the price for "shoes" principally caused 2.2 percent rise in the group index of miscellaneous manufactured articles.

In the special groups, the farm, livestock and fishing products group index and the building materials group index went up 5.0 percent and 2.6 percent, respectively.
